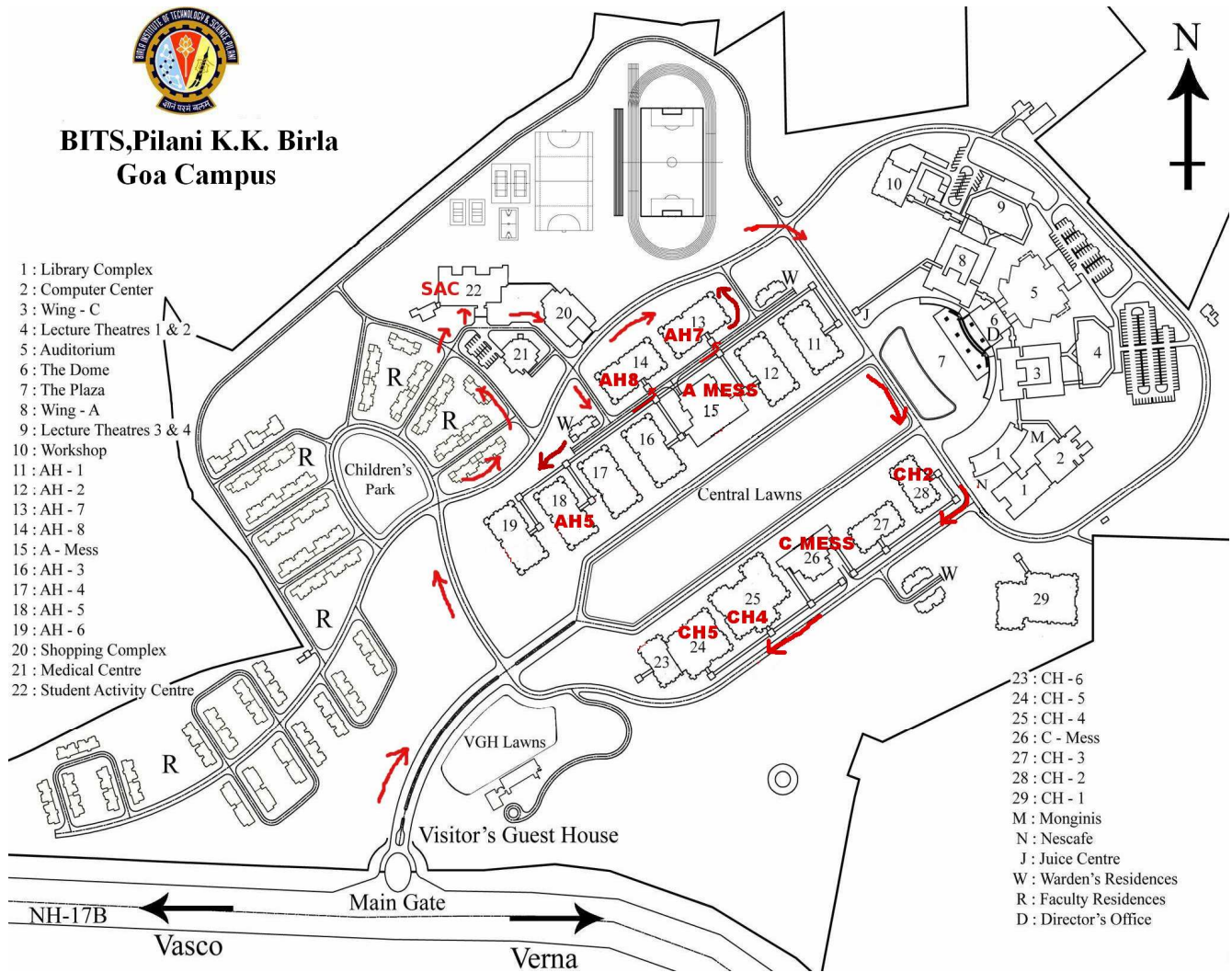

Some Useful Information for new Admission Students

1. Reception of newly admitted Higher Degree (M.E.) students will be arranged from Monday 26th July 2010 onwards. These students have to report for admission on 27th July 2010 at 9:00 am.
2. Reception of newly admitted First Degree (B.E./M.Sc.) will commence from the afternoon of 27th July 2010. These students have to report for admission on 29th July, 2010 at 9:00 am.
3. For details about how to reach the Campus from the Railway Station/Airport/Bus Stand please go to the site <http://www.bits-go.a.ac.in/About%20BPGC/route%20to%20bits.asp> (also accessible from the main BITS-Goa website <http://www.bits-go.a.ac.in> under the link “The Campus” on the main header).
4. On arrival at the Main Gate of the Institute you will be directed to the venue of the Reception. There will be traffic and parking restrictions to ensure smooth flow of traffic.
5. The Reception for Newly Admitted students where Hostel Allotment will take place is at the Student's Activity Centre (SAC) marked above in the Map.
6. Hostel Room will be allotted immediately on arrival. Retain your Taxi/Auto at the SAC. The Hostel Allotment procedure will take about 5 minutes to complete. You can continue in the same vehicle to the allotted Hostel.
7. The student will be allotted a Hostel Room upon arrival at the Reception on producing a printout of Admission Offer Letter from the BITS-Pilani website.
8. The Hostel allotment scheme is as follows: (Refer to Map above)

9. Meals will be served on payment basis in the A and C Dining Halls (Refer Map) from 26th July onwards. From August 3rd, students will be charged on monthly basis.
10. All Hostel rooms are single occupancy and are furnished with cot, computer table, almirah and internet connection and tubelight and fan. The cot size is 6ft x 3ft. Toilets/Bathrooms are shared at the ratio 1 per 4 students.
11. Arrangements will be made so that all the immediate requirements to furnish the room eg., Mattress, Pillow, Bed Sheets, Curtain, Buckets, Mug, Lock etc., will be available at the premises of the Hostel. The Shopping Centre on Campus will also supply all the other immediate requirements.

12. Please remember to bring with you a DD for the specified amount to be submitted on reporting for Admissions. The DD should be made in favor to “**BITS, Pilani -K.K. Birla Goa Campus**” payable at “**SBI, Zuari Nagar**” (Code: 1976) or “**SBI, BITS-Pilani Goa Centre**” (Code: 10720).
13. It is compulsory for all students to have an account in the Campus SBI bank. The Hostel Allotment Slip has to be produced at the SBI Bank branch on Campus to open an account.
14. Parents should minimize their stay on Campus since there are severe constraints on accommodation and resources. There is an interaction of Parents with Director BITS-Pilani, KK Birla Goa Campus at 4:00 pm on 29th July, 2010 which all parents should plan to attend. There is no requirement for parents to stay on and can plan to leave on 30th July 2010.
15. An Orientation Programme explaining all aspects of the BITS educational system will be held on July 30th, 2010. This is meant primarily for the newly admitted student and is not mandatory for parents to attend.
16. Parents of boy students are allowed to stay with the boy in his Hostel room. **Only mothers/female guardians of girl students are allowed to stay in their daughter's Hostel room.** It will not be possible to provide extra rooms for accommodating parents.
